

ORDINANCE NO. 911

AN ORDINANCE OF WATER RATES FOR ALL CUSTOMERS OF DESHLER MUNICIPAL UTILITIES TO PROVIDE FOR THE REPEAL OF CONFLICTING ORDINANCES OR PARTS THEREOF; AND TO PROVIDE FOR AN EFFECTIVE DATE HEREOF.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DESHLER, THAYER COUNTY, NEBRASKA AS FOLLOWS:

Section 1. A schedule of rates based on the monthly consumption of each customer of water serviced from the water system of the City of Deshler, Thayer County, Nebraska, is hereby established as follows:

1. Time period of November 1, 2019 through October 31, 2020:

\$23.25 minimum for a 5/8 x 3/4 inch meter; \$2.40 per 1,000 gallons;
\$24.50 minimum for a 3/4 x 3/4 inch meter; \$2.40 per 1,000 gallons;
\$25.75 minimum for a 1 inch meter; \$2.40 per 1,000 gallons;
\$30.75 minimum for a 1 1/2 inch meter; \$2.40 per 1,000 gallons;
\$39.25 minimum for a 2 inch meter; \$2.40 per 1,000 gallons;
\$57.50 minimum for a 3 inch meter; \$2.40 per 1,000 gallons.

The cost for users outside of the corporate limits shall be 1 1/2 times the above rates.

2. Time period of November 1, 2020 through October 31, 2021:

\$24.25 minimum for a 5/8 inch x 3/4 inch meter; \$2.50 per 1,000 gallons;
\$25.50 minimum for a 3/4 inch x 3/4 inch meter; \$2.50 per 1,000 gallons;
\$26.75 minimum for a 1 inch meter; \$2.50 per 1,000 gallons;
\$31.75 minimum for a 1 1/2 inch meter \$2.50 per 1,000 gallons;
\$40.25 minimum for a 2 inch meter \$2.50 per 1,000 gallons;
\$58.50 minimum for a 3 inch meter; \$2.50 per 1,000 gallons.

The cost for users outside of the corporate limits shall be 1 1/2 times the above rates.

3. Time period of November 1, 2021 through October 31, 2022:

\$25.25 minimum for a 5/8 inch x 3/4 inch meter; \$2.60 per 1,000 gallons;
\$26.50 minimum for a 3/4 inch x 3/4 inch meter; \$2.60 per 1,000 gallons;
\$27.75 minimum for a 1 inch meter; \$2.60 per 1,000 gallons;
\$32.75 minimum for a 1 1/2 inch meter; \$2.60 per 1,000 gallons;
\$41.25 minimum for a 2 inch meter; \$2.60 per 1,000 gallons;
\$59.50 minimum for a 3 inch meter; \$2.60 per 1,000 gallons;

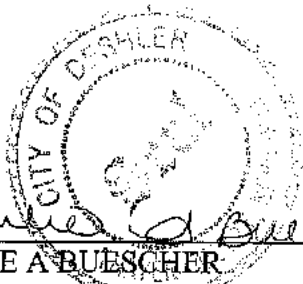
The cost for users outside of the corporate limits shall be 1 1/2 times the above rates.

There shall be a ten percent (10%) penalty applied to all accounts to which this section is applicable that are unpaid as the close of the business on the twentieth (20th) day of the month following the billing period.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. This ordinance shall take effect from and after its passage and publication as required by law.
