AN ORDINANCE OF THE CITY OF DESHLER, THAYER COUNTY, NEBRASKA, TO ESTABLISH SOLID WASTE REMOVAL RATES FOR ALL CUSTOMERS OF THE DESHLER MUNICIPAL UTILITIES; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE FOR PUBLICATION; AND TO SET AN EFFECTIVE DATE

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DESHLER, NEBRASKA:

Section 1. A Schedule of rates for monthly garbage service for all customers of the City of Deshler’s Municipal Utilities Department is hereby as established as follows:
