

APPLICATION FOR CITY UTILITIES

Terms and Conditions

The City of Deshler (the City) is hereby requested to provide utility service at the location herein described (the premises), and to furnish, own and maintain above ground lines and metering equipment located up to and on the premises. As a condition to such service, it is understood and agreed as follows:

1. All private service lines, piping, electric appliances or equipment (excluding above ground lines and metering equipment) located on or within the premises shall be owned, maintained and controlled by the Customer and/or premises' owner. Except as otherwise required by law, the City does not undertake to, or assume the obligation for, the inspection, testing, maintenance, or repair of equipment or facilities not owned by the City.
2. The Customer agrees to pay for electric, water, sewer and sanitation services, and garbage services at the City's established rates as amended and changed from time to time, plus all sales tax. The City may require from the Customer a money deposit sufficient to secure the City in payment of such sums, which may become due by the Customer to the City. The customer further agrees to abide by the City's present and future rules as a condition of utility service. The utility bills are due the twentieth (20th) of each month, and delinquent the twenty first (21st) day of the month. A 10% penalty will be assessed to the electricity and water on the 21st. The policy for disconnection of services for non-payment is adopted within Nebraska State Statutes.
3. The Customer agrees that the City will have the right of access to the Customer's premises at reasonable times for the purpose of installing, reading, inspecting, testing, maintaining or repairing metering and regulation equipment, or for the purpose of removing its property, and for other proper and lawful purposes.
4. City Code § 6-401 et. seq. prohibits certain individuals classified as sexual predators from residing within five hundred (500) feet of certain schools or child care facilities, subject to the definitions, exceptions, and other provisions of City Code and Nebraska law. By signing this Application, the Customer acknowledges this residency restriction and represents that, to the best of the Customer's knowledge, neither the Customer nor any person who resides or is intended to reside at the Service Address is residing in violation of City Code § 6-401 et. seq. The Customer understands that the City's acceptance of this Application or provision of utility service does not constitute a determination by the City that the Service Address or any occupant complies with City Code § 6-401 et. seq.
5. The City shall not be liable for damages due to interruptions in service and the Customer shall hold the city harmless from any and all claims or liabilities for damage or injury to persons or property which may arise out of or be caused by the construction, maintenance, use or operation of service lines, piping, facilities, equipment or appliances which are located on the premises.
6. The Customer shall properly protect the City's property located on the premises from loss or damage.
7. In the event the Customer moves to a different location than stated below, the Customer will be held liable to the City for all service received at the vacated location until payment has been made.
8. The Customer agrees and understands that they will be subject to disconnection and prosecution under Nebraska State law if any metering equipment is tampered with.
9. If the Customer is not the owner of the property, the landlord or property owner's signature is required below ensuring they consent to this application for services and to be held jointly responsible for delinquent charges and disconnect fees.
